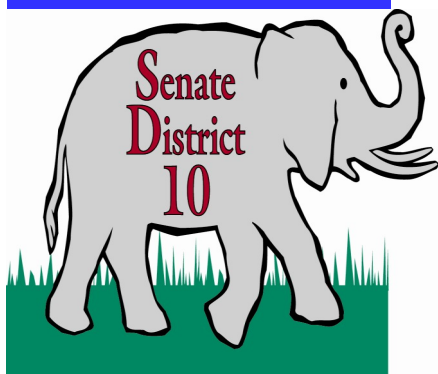

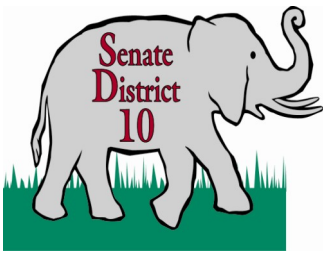

It was during the 11 years that I was employed by the ministry that I was involved in the planning and staffing of the Dallas-hosted National Affairs Briefing where then-presidential candidate Ronald Reagan was the keynote speaker. That was the beginning of my real passion for political involvement.

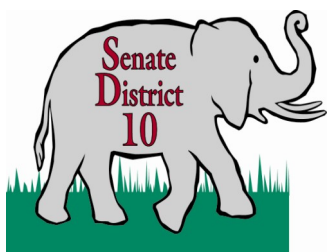

In short, I married my pharmacist, Rey Moreno, a seventh-generation Texan whose ancestors were original Texas land-grant owners in Bexar County. We have four children and one much-loved son-in-law: Melissa is a Navy veteran and a Dallas police officer; Abby is a pharmacy technician and sometimes actress, and her husband Jackie, is a landscape business owner. One thing we enjoy together is hanging out at the ballpark, watching the Rangers play. We're liking this year's PR slogan for our favorite team: "It's time." 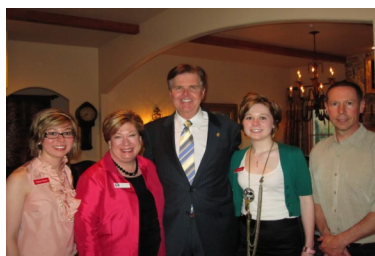

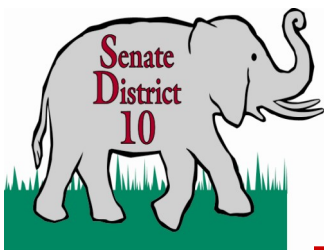

Republican Women of Arlington

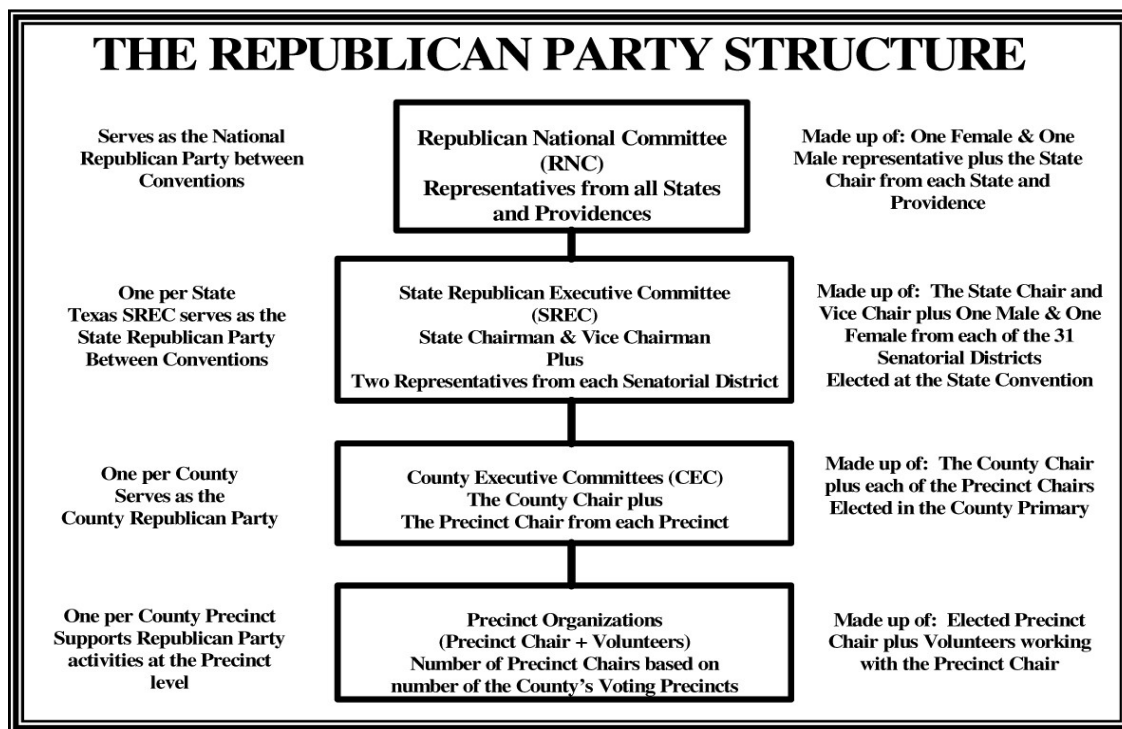

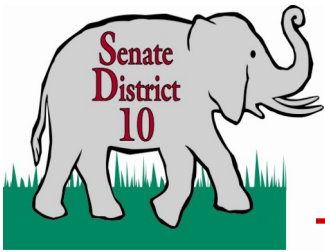


Republican Women of Arlington Board Members

Resolutions Passed By The State Republican Executive Committee March 27, 2010

Resolution Commending Attorney General Greg Abbott

WHEREAS, Greg Abbott has served the citizens of Texas as our 50th Attorney General with great honor and distinction; and

WHEREAS, Attorney General Greg Abbott has a record of vigorously defending our constitutional rights, including his victorious defense of the State Capitol's Ten Commandments monument and his authoring of two amicus briefs to the U.S. Supreme Court on behalf of numerous state attorneys general to affirm law-abiding Americans' Second Amendment rights; and

WHEREAS, Attorney General Greg Abbott has now joined twelve other state attorneys general in filing suit to challenge the constitutionality of the recently enacted federal health care law, which infringes upon Americans' constitutionally protected individual liberties, encroaches upon the states' constitutionally guaranteed sovereignty, imposes an unconstitutional tax, and violates the Tenth Amendment of the United States Constitution; now, therefore, be it

RESOLVED, That the Republican Party of Texas supports Attorney General Greg Abbott's lawsuit to challenge the constitutionality of the recently enacted federal health care law; and be it further

RESOLVED, That the Republican Party of Texas commends Attorney General Greg Abbott for his tireless service to the State of Texas and his zealous defense of the constitutional rights of her citizens.

Adopted by the Republican Party of Texas this 27th day of March 2010.

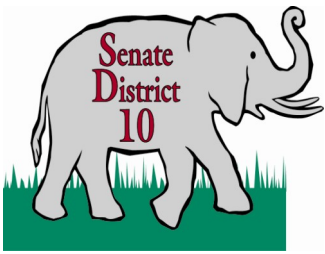


**Chief Justice

Justice Terrie Livingston was appointed by Governor Rick Perry on April 14th to fill the unexpired portion of the term left vacant when former Chief Justice John Cayce retired. She was sworn in April 19th.

On May 22nd, the Republican county chairs within the 2nd Court of Appeals District nominated Justice Livingston to fill the position of Chief Justice on the November ballot.



Resolutions Passed By The

State Republican Executive Committee March 27, 2010

Resolution In Support Of The Texas Open Meetings Act

WHEREAS, The Texas Open Meetings Act was passed in the early 1970s to make government more open and accessible to the public it serves, and recently, several city officials have filed a lawsuit erroneously arguing that open government violates their First Amendment rights; and

WHEREAS, Several cities are using taxpayer dollars to pursue lawsuits, and the Texas Municipal League, a taxpayer-funded lobby group, has endorsed lawsuits to gut the Texas Open Meetings Act; and

WHEREAS, Many city officials are trying to weaken the Texas Open Meetings Act by removing its criminal penalties;

THEREFORE BE IT RESOLVED, That the Republican Party of Texas supports the Texas Open Meetings Act as currently written and opposes the use of taxpayer dollars for filing lawsuits to weaken open government laws and similar examples of taxpayer-funded lawsuit abuse, and

BE IT FURTHER RESOLVED, That the Republican Party of Texas commends Attorney General Greg Abbott for his commitment to open government and defense of this important legislation; and

BE IT FURTHER RESOLVED, That the Republican Party of Texas condemns the actions of the Texas Municipal League in attacking open government and calls on elected officials in cities involved to stop using taxpayer dollars for this purpose immediately; and

BE IT FURTHER RESOLVED, That the Republican Party of Texas encourage Republican members of the Texas Legislature to take steps to investigate and curtail taxpayer-funded lawsuit abuse; and

BE IT FURTHER RESOLVED, That a copy of this resolution be sent to Attorney General Greg Abbott, the cities that are involved in this lawsuit, and all Republican members of the Texas Legislature.
